#### DIOCESAN FINANCE COUNCIL

The Diocesan Finance Council is a consultative body for the diocesan bishop and, as with parish finance councils, is required by the Code of Canon Law, the universal law of the Catholic Church. The specific responsibilities of the diocesan finance council, as outlined by canon law, include reviewing the annual budget, annual financial statements and the independent auditors' report, and providing consultation in specific financial areas. In the Diocese of Greensburg, there are statutes that provide further direction for the council, including advising the bishop and his staff in the Department of Finance. # Diocese of Greensburg on strong financial foundation moving forward

The Diocese of Greensburg has a stable, strong financial foundation as of the end of the fiscal year, June 30, 2018. The Statement of Fi-

nancial Position outlined in this report indicates that the diocese's total unrestricted net assets have increased by about \$2.3 million since June 30, 2017. This is mainly attributed to the decrease in the net asset deficit

in the Pension Accounting Fund resulting from solid investment earnings.

However, both the Pastoral Center and the Self Insurance Fund net assets decreased by about \$1 million, and \$2 million, respectively, since the previous year. An increase to the allowance for uncollectible accounts was mainly the source of the decrease in the Pastoral Center, and an increase in property and health claims resulted in the \$2 million decrease in the Self Insurance Fund.

The Statements of Activities for the Diocesan Central Administration reflects the generous support that parishioners continue to give to the diocese. The diocese's share from the Diocesan Lenten Appeal increased more than \$100,000, with the parishes retaining about \$1.5 million of the 2018 appeal. The diocese recognized an increase in the expenses allocated to the Catechesis, Evangelization, Youth and Worship offices so that it was able to continue to spread the Good News to all. The remaining department expenses remained fairly

consistent year to year, with the exception of the bad debt expense that was recorded to reflect the increase in the allowance for uncollectible

> accounts from our parishes and schools. These accounts may still be collectible in the future, and the allowance would be adjusted annually to reflect this possibility. The Diocesan Central Administration ended

the year with net assets of \$6.7 million, or approximately \$1 million less than the previous year.

Due to the Grand Jury investigation. which concluded with the release of a report in August 2018, and ongoing legal issues, the diocese continues to incur legal fees. The total legal fees of approximately \$430,000 and \$390,000, respectively, are noted on the Diocesan Central Administration Pastoral Center Statement of Activities for the fiscal years ending June 30, 2018 and 2017. The majority of these fees are related to the Grand Jury investigation. The Self Insurance Fund also paid a portion of the legal fees related to the investigation, which was \$421,000 and \$380,000, respectively, for the fiscal years ending June 30, 2018 and 2017, as well. The diocese does not pay the legal fees to defend a priest accused of sexual abuse.

The two diocesan schools, Greensburg Central Catholic Junior-Senior High School (GCC) and Geibel Catholic Junior-Senior High School (Geibel Catholic), continue to provide an outstanding education to students in the Diocese of Greensburg. GCC ended fiscal year 2018 with a \$292,000 change in net assets, which decreased its net asset deficit down to about \$1 million. Tuition income and other revenues remained consistent year to year, but GCC realized a reduction in instructional expenses due to a retirement buy-out package that was offered at the end of school year 2016-2017.

Geibel Catholic's net assets increased more than \$300,000, and the school ended the year with a net asset balance of \$449,000 on June 30, 2018. The school retired its outstanding loan for the 1:1 computing initiative early, which is reflected as the zero balance for the Catholic Institute loan payable. Tuition revenue was lower as compared to school year 2016-2017; however this decrease was offset by the addition of an in-house cafeteria that resulted in gross income of about \$100,000 for the current year. The development income also increased by more than \$60,000 as well. Total expenses remained constant year to year, which resulted in the change in unrestricted net assets of \$326,000.

The Diocese of Greensburg continues to be financially stable and manages its mission within the resources provided by faithful and generous benefactors. On behalf of Bishop Edward C. Malesic and the Diocesan Finance Council, I am available to answer any questions you may have about the financial position and annual results of the Diocese of Greensburg.


#### ABOUT THIS REPORT


