# Analysis from the chief financial officer

I am pleased to present the overview of the finances of the Diocese of Greensburg for the fiscal year ending June 30, 2019. The full audited financial

statements, as well as other supplemental financial information, are available at theaccentonline. org. As the people of God work with the diocese and its parishes, we will continue to be able to offer the variety

of ministries to all Catholics and the people of Armstrong, Fayette, Indiana and Westmoreland counties.

The pie charts below show where the funding comes from to support the central administration offices, as well as the cost centers where those funds were spent. The Diocesan Lenten Appeal continued to be the greatest revenue source with 32% of diocesan revenues. The assessment on parish offertory and other extraordinary income, an 8% assessment, generated another 25% of diocesan income. Program fees and other revenue, the fees charged to parishes for hospital ministry services, as well as government funding received for Catholic schools, generated 15% of the revenues. Christ Our Shepherd Center generated more than \$800,000 from lease income for central administration budget and another \$500,000 in food service and overnight lodging income.

Investment income rounds out the top five revenue sources, providing about 8% of our diocesan revenue.

Faith formation and Catholic education expenses accounted for 20% of the total expenses of the central administration offices. The finance department — which includes finance, facilities and information technology — was about

\$1.7 million, or 16% of total expenses. Approximately 13% of expenses was for vocations, clergy formation and international priests programs, while

the corporal works of mercy, which provided materials and services to people in need, was \$1.3 million.

Legal and professional fees are included in the "Other" administration category, which was 6% of total spending. The diocese incurred legal fees of approximately \$600,000 in

fiscal year 2019, \$400,000 in fiscal year 2018, and another \$400,000 in fiscal year 2017. These fees were all due to state and federal grand jury investigations and the establishment of the diocese's Survivors' Compensation Program.

On the Statements of Financial Position posted on theaccentonline.org, our fixed assets, net of depreciation, have decreased by about \$3.4 million since June 30, 2018, due mainly to additional depreciation expense incurred as we adjusted the lives of our fixed assets. This one-time adjustment occurred during the fiscal year ending June 30, 2019. Sale of fixed assets was not part of this decrease.

In the Liabilities section, accrued expenses increased about \$4 million. This included the \$4,350,020 settlement amounts paid from the Survivors' Compensation Fund to survivors of clergy sexual abuse early in fiscal year 2019-20. The accrued pension-lay plan liability also increased about \$4 million due to a change in the discount rate and investment rate when calculating this liability.

Net assets without donor restrictions, previously identified as unrestricted funds, decreased \$15 million since June 30, 2018. The Self-Insurance Fund decreased by \$5 million

due to the settlement amounts cited previously, along with legal fees of about \$700,000 related to the state and federal grand jury investigations and the diocese's Survivors' Compensation Program. The Plant Fund fixed assets decreased by the \$4 million due to the adjustment to the lives of the fixed asset. The Pension Accounting Fund net assets also decreased by \$5 million with the adjustment in the discount and investment rates. Both the depreciation expense and pension adjustments were an accounting requirement and not a reduction in cash.

The two diocesan high schools — Greensburg Central Catholic Junior-Senior High School and Geibel Catholic Junior-Senior High School which continue to provide a quality, affordable education, both incurred additional debt to finance the purchase of new laptops for all students. These amounts are reflected on the schools' respective Schedules of Assets, Liabilities and Net Assets. Both schools also received additional EITC funds during fiscal year 2019, which will be distributed as financial aid to qualified students during the 2019-20 school year. We continue to work to increase EITC funds from our generous donors to help maintain an affordable education.

In conclusion, the diocese's financial results show that the Catholics of our diocese continued to be most generous this past year. As the diocesan mission statement proclaims, the Catholics of this diocese — priests, deacons, religious and laity - work together to live out their baptismal call to proclaim the Gospel of Jesus.

We are most grateful to all who demonstrate their commitment to responsible stewardship.

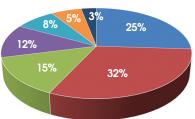
